## Section 2: HAZARDS IDENTIFICATION

**Classification:** This substance does not need to be classified according to regulation (EC) No. 1272/2008.  
**Label:** This product does not need to be labeled in accordance with EC directives or respective national laws.  
**Other hazards:** This product contains protein of bovine origin. Each animal has been tested according to EU food safety standards. However, no known test can offer complete assurance that disease transmitting agents are not present. Handle as if capable of transmitting infectious agents.

**General information:** Aqueous solution of non recombinant bovine Ro/SS-A (60 kDa).
